



## **Privacy notice for the registration of beneficiaries to "Sembrando Vida" Project in Belize.**

The **Mexican Agency for International Development Cooperation**, through the **General Directorate for the Execution of Special Projects of International Cooperation**, with address at Plaza Juárez 20, 7th floor, Colonia Centro, Alcaldía Cuauhtémoc, C.P. 06010, Mexico City, is responsible for processing the personal data that you provide for the "Sembrando Vida" Project in Belize, which is protected by the General Law on Protection of Personal Data Held by Obligated Entities, and other applicable regulations, for which we inform you the following:

### **What personal data could be collected and for what purpose?**

- Full name
- Date of Birth
- Age
- Gender
- Nationality
- Place of residence
- Marital status
- Economic dependents
- Profession or occupation
- Photography
- Signature
- Biometrics (fingerprints)
- Bank account number
- Phone number
- Email

### **Sensitive personal data**

- Information regarding health status

### **Required digitized documents containing personal data:**

- Official identification
- Proof of address
- Proof of ownership, proof of land ownership and/or legal instrument that proves possession of the property

The personal data collected will be used to verify whether the applicant who intends to join the Project meets the requirements established in the "Technical File for Sembrando Vida in Belize", as well as to fully identify their nationality and place of residence and, if applicable, the document that certifies the possession or ownership of the property that will be recorded in the registry, the capture of their biometric data for their incorporation

in the list of beneficiaries, in addition to the bank account number where the monthly economic support will be deposited.

### **Legal basis for the processing of personal data**

As a decentralized body of the Secretariat of Foreign Affairs, the treatment that the Mexican Agency for International Development Cooperation through the General Directorate for the Execution of Special Projects of International Cooperation, gives to the personal data indicated, will be done in accordance with what is established in article 28 section I and XII of the Organic Law of the Federal Public Administration, articles 7, 10 section I, IV, VII, X and XI of the Law of International Cooperation for Development, article 65 and 71 section I, II, III, VI, XII and XVII of the Internal Regulations of the Secretariat of Foreign Affairs, as well as what is stated in articles 4, 16, 17 and 18 of the General Law of Protection of Personal Data in Possession of Obligated Subjects.

### **Transfer of personal data**

Furthermore, personal data will be transferred to the following public and private entities:

- Banco del Bienestar, Sociedad Nacional de Crédito, Institución de Banca de Desarrollo of the Government of Mexico.
- Ministry of Agriculture, Food Security and Enterprise of the Government of Belize.
- Heritage Bank Limited.

Except for those that are contemplated in article 70 of the General Law on Protection of Personal Data Held by Obligated Subjects, in order to carry out audits and evaluations of the "Sembrando Vida" Project in Belize.

### **Where you can the rights of access, correction/rectification, cancellation or opposition of personal data (ARCO rights) be exercised?**

Finally, you may exercise your rights of Access, Rectification, Cancellation or Opposition of your personal data (ARCO Rights), through the procedure established for this purpose in the General Law on Protection of Personal Data in Possession of Obligated Subjects and other applicable provisions on the matter.
